## **County Code Compliance Request Process**

- 1. Receive compliant.
- 2. Investigate to determine if a violation exists.
- 3. If a violation does exist, the property owner or violator will be contacted and informed of the violation, what actions are needed to remedy the situation, and given a specific compliance deadline date.
- 4. On the compliance deadline date, Code Enforcement Staff will verify that compliance has been attained. If this is found to be the case, the file will be closed.
- 5. If, upon re-inspection, the violation still exists, the property owner or violator will be contacted and again requested to comply. The second notice may include a date in which a citation may be issued/or further enforcement measures applied if the problem has not been resolved.
- 6. After the citation deadline is reached, a site visit is made to determine if the matter has been corrected. If the violation still exists, a citation may be issued and the case information prepared for Administrative Hearing.

Due to the large volume of complaints processed, it is difficult to maintain up to date status reports to complainants. Please feel free to check in with the Code Enforcement Staff if you would like to find out the current status of a complaint.

Different types of complaints and violations have somewhat different time frames for compliance based on a number of factors including public safety and ease of corrective activities required. The intent of the compliance process is to be as fair as possible to all parties involved and to ensure that the livability of our community is maintained through communication, education, and mutual respect.

It is encouraged that citizens refer to the County Code to provide a basis for a complaint, and if possible, communicate directly with the responsible party to the complaint in efforts of resolving the matter privately.
