A supplemental bill will be invoiced to the applicant for the cost of staff time that exceeds the permit fee collected. Staff time will be billed at \$75.00 per hour.

### Pebble Beach Drive Lift Station 5 Fee

A Development Fee is required for each ESFC discharging from the Pebble Beach Drive Lift Station (Lift Station 4). The fee is adjusted each fiscal year based on the Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W). Below is the method to calculate the fee for each ESFC.

January 1 to June 30: \$1,424 X ((Two Years Previous Annual CPI-W)/134.3)  
July 1 to December 31: \$1,424 X ((One Year Previous Annual CPI-W)/134.3)
