**Fields Available for Reservation:**

Pykes Field: 1005 H Street Crescent City, CA 95531  
2 Adult Softball with lights

**Use of softball fields for purposes other than for softball or baseball activities:**

Field Reservations are restricted to rentals for softball or baseball activities only. Any desired use of softball or baseball fields other than for the sport of baseball or softball will require special approval from the Recreation Coordinator. This restriction is to preserve the integrity of these competition playing fields for the purposes for which the complexes were built.

**Tournament (all day) Rentals:**

Rental Rates and deposits for tournaments (all day rentals) are determined by the number of fields needed.

**Rental Fees and Deposits:**

At the discretion of the Recreation Coordinator (typically \$100.00 per field/per day)  
\$ 30.00 for each score panel, if available, per tournament.

**Basic Rental Information for Tournament/All Day Rentals:**

1. The Rental Fee pays for the field(s) and bases, the fields will also be drug and lined before the tournament begins each day.
2. Before a date can be reserved the applicable fees must be paid.
3. The applicant(s) in charge of a tournament must meet with a Recreation Coordinator from the Del Norte County Recreation Department, before the tournament to arrange any tournament and maintenance details (additional maintenance requirements such as lining and dragging the fields will be an extra charge to the renter and must be arranged in advance of the tournament).
4. Irrigation clocks are not to be tampered with.
5. Absolutely no alcoholic beverages are allowed on the fields or in the dugouts.
6. Vehicles are not to be driven or parked on the grass or non-designated areas without prior approval and proper identification. Absolutely no vehicles are allowed on the fields.
7. The Del Norte County Recreation Department reserves all concession rights. The concessions stands have been contracted out to local organizations who will be notified of tournaments. The concessionaires have the first right of refusal to operate the permanent stand during tournaments. Should the vendor waive the right to operate during tournaments, and the tournament director desires to have souvenir or approved beverage/concession sales available throughout the duration of the tournament, approval of sales must be obtained from the Recreation Director prior to the event.
8. To use the facility after 11:00pm, a written request must be submitted to the Recreation Department for approval.
9. The Recreation Department reserves the right to cancel tournaments for any of the following reasons:

- a. Weather Conditions
- b. Scheduling Conflicts
- c. Field Conditions

10. An Applicant shall have the opportunity to move their date if they meet the following criteria:

- a. Cancellation must be made in writing seven working days prior to the tournament date. Failure to notify the Recreation Department within the seven-day period will result in the loss of 25% of field rental.
- b. Unplayable field conditions as determined by the Recreation Department

11. Tournament Reservations – Tournament reservations may be made as early as the first working day of the new calendar year through the Del Norte County Recreation Department.

12. Renting party may not deny access to Del Norte County Recreation Department personnel at any part of the facility.

### **Insurance Requirement**

A certificate of General Liability insurance in the amount of \$1,000,000 coverage will be required. Certificate must be presented to the County Risk Management prior to tournament. To the extent the applicant has employees, it agrees that it has obtained workers compensation as required by California law.

### **Indemnification/ Waiver of Rights**

Applicant takes sole responsibility for tournament as well as his/her guests, contractors, agents, employees, or assigns. Applicant shall defend, indemnify and hold the County, and its officers, employees and agents harmless from any and all loss, damage, claim for damage, liability, expense, or cost, including attorneys fees (which shall be interpreted to include County Counsel fees), which arise out of or is in any way connected with the use of the Facility or any County equipment in the facility. This indemnification provision shall apply to any acts or omissions, willful misconduct or negligent conduct, whether active or passive, on the part of the Applicant or his/her guests, contractors, agents, employees, or assigns. Applicant waives any right to a cause of action relating to use of the premises and fully assumes the risks of use of such. Applicant further acknowledges that the County, his/her agents, staff, officials, or officers make no warranty with respect to any of the equipment used for the activity whether expressed or implied. Applicant specifically agrees to indemnify the County costs or expenses arising out of his/her use of the premises related to the tournament including the cost of medical care, and any expenses or fees incurred in any lawsuit arising as a result of any damage or injuries caused by Applicant or his/her guests, contractors, agents, employees, or assigns.
